COST

As a Government Funded Program approximately 90% of your tuition fee is paid by the NSW Government. You are expected to pay a student contribution fee of \$958. Please note: students who are in receipt of Centrelink payments may qualify for a fee exemption or further concession. For further information call the Academy today.

PRE-REQUISITES

The Certificate IV in Beauty Therapy does not require any pre-requisite studies, however, participants must have successfully completed Year 10 and be at least 16 years of age.
